Parish Council Vacancy

Following our notice of a casual vacancy, we are pleased to welcome Cllr Mike Dixon to the parish council. We would like to thank the other parishioners who applied and it was very encouraging to see that a number of people were interested in filling the vacant role. Skate Park

We are looking at options for updating the equipment in the skate park as we recognise that some of it is coming to the end of its life and is posing an increasing challenge to maintain. This is likely to be a long-term project, necessitating securing funding, but is something that we hope to keep moving along in the background.

Unfortunately we are still seeing some instances of anti-social behaviour, including the setting of small fires in the park. If you see anything suspicious please let us know or contact Thames Valley Police.

High Street Flooding

As we reported last time, there remains an ongoing issue with water pooling around the gullies outside the Co-op and on the corner of Sheards Lane. OCC Highways believe they have identified a collapsed pipe in this area, and we will endeavour to ensure that addressing the problem receives priority.

QEII Recreation Field Update

As we said in the last parish council newsletter, we have submitted the planning application for the first stage in our project for a new recreation field on the land at the top of Cottage Road, opposite the Football Club.

We are working through the consultation responses received, which has necessitated some minor modifications to the layout and some additional ecological surveys which will be in progress in the coming months. In addition we have also been carrying out some drainage tests in the field to ensure that any changes we make do not impact the surrounding fields and roads. Particular thanks are due to Darren Rolls for helping us with the tests.

Litter picking

Our thanks to the Stanford in the Vale WI, who spent their morning litter picking in the QEII Recreation Field, the Community Woodland and Strip woodland. Between eleven people they collected nine bags of rubbish. Ideally, this would be one of those jobs that didn't need doing – please remember to take any rubbish home with you or use one of the litter bins around the village.

Footpaths

We're pleased to report that the collapsed stile on the one of the popular circular walks south of the village has now been repaired by the county council footpaths team. We're sorry it has been out of action for quite some time, but arranging these types of repairs is not always straightforward. We're grateful to the county council for their work to fix it.



Law surrounding virtual council meetings

The expiry of the law permitting virtual council meetings in England at the beginning of May has placed the parish council in a difficult position – wanting to safeguard the health of councillors and parishioners on one hand and abiding by the law on the other.

After discussion at the last council meeting we have decided to hold our next meeting, in June, remotely, as we have been doing since the start of the pandemic. The council felt that our duty of care towards members of the public and councillors, particularly those who may still be shielding, overrode the legal position.

We will be reviewing this again at our next parish council meeting.

And finally

At the last council meeting Cllr Peter Lewis stepped down as chair after a number of years. We're very grateful for all he has done for the village in the role and also pleased that we'll continue to benefit from his contribution to the council as deputy chair.

PROTECT YOUR POOCH

Dog theft is on the rise and we are urging the public to keep their dogs **SECURE**, **IN SIGHT** and **SEARCHABLE**, and to help make pet theft a **SPECIFIC OFFENCE**.

Keep them:

- 1. SECURE** (pets are easily stolen from unsecured gardens if left unattended)
- 2. IN SIGHT** (when out and about keep them close and practice good recall)
- 3. SEARCHABLE** (to support quicker recovery if they go missing keep them microchipped, tagged and up to date photos)
