



### Changes at the Household Waste Recycling Centre (the Tip)

Oxfordshire County Council have changed the way we can use the Tip from 14<sup>th</sup> January. 2026. The principal changes are:

- Before going to the tip, you will need to book in.
- People can book 30 minutes before their visit (subject to availability) or up to two weeks in advance.
- When going to the tip, you need to take proof of address with you. This is intended to help charge people who do not live in Oxfordshire to use the Tip.

The Parish Council also thank the William-Cuss family for donating a new tree which has been planted on Church Green to replace the diseased tree that had to be cut down.

### Parking on Highway Verges and Village Greens

Please can we make another plea that everyone avoids parking on all grass highway verges and particularly the Village Greens. As we move into late winter and spring we can all see the damage caused by vehicle ruts. Please park considerately. If accessing your own property to park, a dropped kerb application should be made to the County Council to provide safe access.

### Village Wayfinder Trail

We have recently submitted a planning application in relation to the siting of the stones that will form our Wayfinder Trail. We have reviewed and considered all of the comments submitted by members of the public in relation to this. The Parish Council would like to stress that none of the cost of the Wayfinder Trail is being met from Precept/Council Tax. The money to fund public works of art is part of developer contributions in relation to housing developments in the village. The planning permission(s) granted by Vale of White Horse District Council determine that these funds must be spent on Arts Projects in the village. If the money is not spent within 5 years the money is returned to the Developer. It was in response to this 'use it or lose it' grant funding that your Parish Council has created the concept of a Wayfinder Trail. We have aimed to consult with parishioners on their views and the artist involved worked with the village school to develop the ideas within. We firmly believe that this project will be an asset to our community for many years to come.

### Thames Water Verge Repairs

The Thames Water repairs to the highway verge in High Street are most unsatisfactory. The Parish Council are pushing Thames Water to re-instate the verge at the previous level.

## Council Tax Precept for SITV Parish Council

Every year, the Parish Council reviews our financial commitments in order to determine and set an appropriate budget and by consequence the parish precept, which is included within your Council Tax. We have historically done our utmost to keep the precept as low as possible, whilst aiming to maintain a high standard of services to local residents. By way of example, in the financial year ending March 2025, we secured significant sums from other sources (for example grants), allowing us to spend over £110k within the village against a total precept charge of just £30k.

At the Parish Council meeting in January, taking into consideration our estimates for the forthcoming financial year, it was agreed that, with careful management, the Precept would be set at £33,408, the impact for a Band D dwelling within the village would be less than 90p. Of course, this is against a backdrop of increased pressures from inflation, cost of materials and wage increases for staff/contractors.

Of course, the Council Tax that we all pay adds in more substantial costs from District, County and Policing but we thought that it would be useful to see what your Parish Council is spending. Below is a comparison with the Precept from other some other Parish & Town Councils in our area (for the year to April 2026):

Parishioners will no doubt be pleased to know that your Parish Council spent almost £100,000 more in the village than it raised through Council Tax. We raise the rest of the money through grant applications etc. We do not borrow money and have no debt.

## New Quarry Shellingford

This is currently going through planning at County Council. There will eventually be up to an additional 100 HGV vehicles per day on the A417. We have responded to the consultation outlining a number of concerns, particularly in relation to traffic management and the road network which we believe the County Council should address. The Parish Council has now trialled monthly surgeries in the village café for 6 months. On most occasions no parishioners have attended.

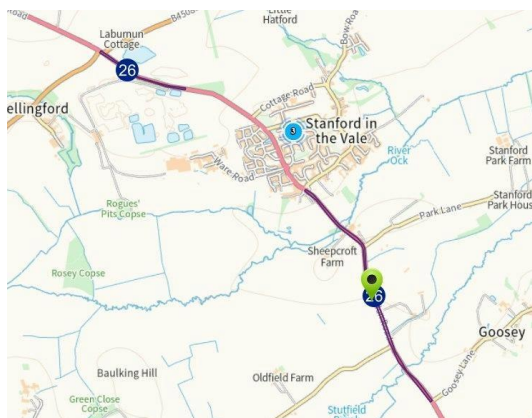
We have therefore decided to hold ad-hoc surgeries about every 6 months instead. Details will occur in future newsletters

## Extract from a detailed report from our County Councillor – Lee Evans

### Resurfacing the A417

After multiple attempts to get the road repaired resulting in short-term patching which soon failed, I am very pleased to be able to say the A417 by Stanford Mill and the Shellingford cross-roads is on the list to be resurfaced in the next financial year.



This is a big step forward for improving the roads in our area - and, when it happens, will make a real difference to the A417. But this isn't yet 'job done', for a few reasons.

There are still issues with drainage on the road, which need addressing, and the resurfacing isn't due until the next financial year, when there needs to be more urgent action this winter.

### Water on the road – A417 near Stanford Mill

Residents have been in touch about issues with water on the road by Stanford Mill.

I raised this as an urgent issue with the highways team, and contacted Thames Water about it, too.

At the time of putting this report together, I'm waiting for updates from both.
